These teams were engaged in constructing homes, providing medical assistance, caring for the needs of community members, training leaders, and engaging in relationships that will help the locals identify their own resources and potential. Heart to Honduras arranges travel, lodging and meals through Honduran partner Corazon Para Honduras.

4b (Code:) (Expenses \$ 379,985 including grants of \$ 31,425) (Revenue \$) Other programs by Heart to Honduras include pastor training, leadership development, community development, health care, education, and operational support to Corzon Para Honduras.

4c (Code:) (Expenses \$ 272,541 including grants of \$ 129,059) (Revenue \$) Heart to Honduras is equipping communities with sustainable models of work and development to provide clean water, secure housing, accessible medical care, a consistent food supply, adequate fair employment, as well as spiritual and educational opportunities. In 2015, Heart to Honduras built 31 homes, 35 sink/water sources, and 2 bathrooms. The organization was also engaged in 25 various projects including building roofs and retaining walls, providing educational support to local communities and supporting agricultural initiatives.
